PROFILE OF SPEAKERS

HER LADYSHIP JUSTICE GEORGINA THEODORA WOOD



Her Ladyship Justice Georgina Theodora Wood is a member of the Council of State and former Chief Justice of the Republic of Ghana. She was appointed to the Bench as a Magistrate of the District Court in 1973 and rose through the hierarchy of the court system to become the first female Chief Justice of Ghana. Between 2003 and 2007, she served as a justice of the Supreme Court of Gambia when in session. She is an advocate of Alternative Dispute Resolution (ADR). She was a member of the task force which designed the Ghana Court-connected ADR program and was the Chairperson of the working committee which drafted the manuals on Court connected ADR and pre-trials in the Commercial Court of Ghana.

She also chaired the committee responsible for mainstreaming ADR in the courts in Ghana. She has lectured extensively in ADR (theory and practice) at the Judicial Training Institute, training key personnel including judges, lawyers and civil society organizations. She taught Civil Procedure and ADR in the Judicial Service Career Magistrates Programme, and was an external examiner in advocacy and ethics, Ghana School of Law for over 10 years. Justice Wood also co-authored the practice manual on the Gambian ADR court- connected programme and has also been a Judicial educator in ADR for the Bench, the Bar and court officials in the Gambia.

HIS LORDSHIP WILLY MUTUNGA



Willy Mutunga is a Kenyan lawyer, intellectual, reform activist, and was the Commonwealth Special Envoy to the Maldives. He is also an active member of the Justice Leadership Group. He is the retired Chief Justice of Kenya and President of the Supreme Court of Kenya.

Dr. Mutunga has published two books: The Rights of Arrested and Accused Persons (Nairobi: Oxford University Press, 1990) and Constitution-Making from the Middle: Civil Society and Transition Politics in Kenya, 1992-1997 (Nairobi and Harrare: Sareat/MWENGO, 1999). He has also published many essays and papers on human rights, law and society and co-edited and co-authored several books.









NANA PROF. S.K.B ASANTE



Nana Prof. S.K.B Asante a Ghanaian lawyer and the Paramount Chief of Asokore Asante in the Ashanti Region of Ghana. He was an International Arbitrator, and served as International Court of Arbitration of the International Chamber of Commerce, International Centre for Settlement of Investment Disputes (ICSID). He was an Honorary Chancellor of the Graduate School of Governance and Leadership and a Visiting Professor at the University of Ghana.

He holds an Mphil in African Studies from the University of Ghana and a JSD from Yale University Law School. He also holds an LLB from the University of Nottingham and LLM from London University.

HON. CHIEF FORTUNE CHARUMBIRA



Hon. Chief Fortune Charumbira is the President of Zimbabwe Chiefs' Council and the Vice President of the Parliamentary Organ of the African Union - Pan-African Parliament in South Africa.

HIS LORDSHIP STEPHEN BROBBEY



Stephen Alan Brobbey is a retired jurist. He was a justice of the Supreme Court of Ghana and once served as Chief Justice of the Gambia.

Prior to his retirement he served as the chairman of the Automation Committee of the Ghana Judicial Service, a committee whose core mandate is to mechanize courts throughout the country. In 2018 he was made chairman of the board of governors of the Economic and Organised Crime Office (EOCO), that same year he was appointed by the government of Ghana to chair the Commission of Inquiry into the creation of new regions.







DR. E. KOFI ABOTSI



Dr. E. Kofi Abotsi is Dean of the UPSA Law School and the Managing Partner at Axis Legal. He holds significant publications to his credit in leading peer review journals and has covered extensive fields in law including constitutional and comparative law, development law, International Human Rights law and customary law reform. He also has a rich experience in criminal justice administration especially in the area of police capacity building and legal sector reform projects. He holds a Master of Law (LL.M) Degree from Harvard Law School and a PhD from the University of Milan, Italy.

PROF. MATTHEW DILLER



Prof. Matthew Diller is the Dean of the Fordham Law School and a prominent scholar of social welfare law and policy. He has lectured and written extensively on the legal dimensions of social welfare policy, including public assistance, Social Security, and disability programs and on disability law and policy. 
BENEDICTA LASI

He has also acted as consultant to the Kenya 2010 Constitutional Process, Zimbabwe Constitutional Process, Somalia, and Sudan.

He has published 19 books, 29 book chapters and over 100 articles in academic journals. He is Honorary Professor of Law, Faculty of Law, University of Cape Town, Extraordinary Professor of Law, University of the Free State South Africa, Extraordinary Professor of Law, University of the Western Cape, South Africa, and was formerly Professor of Law and Dean of the School of Law at the University of Zambia. He has been an arbitrator under International Chamber of Commerce (ICC).

PROF. SANDRA F. JOIREMAN



Prof. Sandra F. Joireman is the Associate Provost for Faculty, Weinstein Chair of International Studies, and Professor of Political Science at the University of Richmond in Richmond, Virginia. She specializes in comparative political economy with an emphasis on Africa and the Western Balkans. Her work covers topics related to property rights, legal development, and post-conflict migration. PROF. ANTHONY C. DIALA



Prof. Anthony C. Diala is Associate Professor of Law and Director of the Centre for Legal Integration in Africa at the University of the Western Cape. He is a legal anthropologist, an advocate, and a National Research Foundation of South Africa rated researcher. His interdisciplinary research focusses on legal pluralism, specifically the interplay of African customary law and state law, and their effect on law reforms and legal emancipation. 
PROF. JANINE UBINK
